Free School Meals

While on the subject of school budgets, I feel it is worth mentioning that all children in reception, year 1 and year 2 automatically get universal free school meals.

However all parents and carers are encouraged (*really* encouraged) to apply for free school meals if you are in receipt of any of following, as this can help to attract additional '[pupil premium](#)' funding to support your child's learning.

To qualify for free school meals parents need to be receipt of one of the following:

- Income Support
- income-based Jobseeker's Allowance

- income-related Employment and Support Allowance
- support under Part VI of the Immigration and Asylum Act 1999
- the guaranteed element of Pension Credit
- Child Tax Credit (provided you're not also entitled to Working Tax Credit and have an annual gross income of no more than £16,190)
- Working Tax Credit run-on - paid for 4 weeks after you stop qualifying for Working Tax Credit
- Universal Credit

Not only will your child receive a free school meal once they are in Year 3, but you will be helping to secure an additional £1320 per eligible pupil for the school to support the children.

Holiday Requests

Please be advised that Devon County Council are now issuing penalty notices for unauthorised absences and therefore parents and carers will be required to pay fines for unauthorised absences during term time. Please be advised that as a general rule holidays will not qualify as exceptional circumstances and will not be authorised.

Penalty Notices Penalty notices will require the parent of a child of compulsory school age, whose attendance has been unsatisfactory, to pay a fine, currently £60.00 if paid within 21 days or £120.00 if paid within 28 days. In Devon, penalty notices will be issued by the Legal Proceedings Officer employed by the Council and based within the Education Welfare Office. The Legal Proceedings Officer will ensure that the issuing of penalty notices is closely monitored and that recipients pay the relevant fine. In any case where the penalty is not paid within the appropriate period, the Local Authority will instigate action through the courts as required by legislation. A penalty notice will only be issued to a parent(s) if the pupil has at least ten, half-day unauthorised absences recorded against their name within the previous six months.

Absences

Parents and carers are reminded to contact the school by 9.30am if their child is going to be absent from school due to illness. Please contact the school absence line on 01404 815780 and leave a message or email absence@ottery-primary.devon.sch.uk. If your child has an appointment that you know about in advance, please ensure you have informed the office. Please do not rely on children to pass on messages, instead please write a short note to the office staff or let us know by phone or in person at Reception. The school has a duty of care to know the whereabouts of children and when we have not been informed of the reason for a child's absence the office staff have to spend time phoning various contact numbers to find out the reason for child's absence from school.
